All vehicles driven to school must be on the permit application. Any vehicle changes during the school year must be immediately reported to the parking lot attendant or to the front office.

In order to purchase a parking permit, students must return the completed application with both signatures and the \$50.00 semester fee. Only one application is required per year.

PARKING RULES AND REGULATIONS

1. Motor vehicles parked on school grounds must visibly display a valid semester permit from their rear view mirror. Cars without a visibly displayed permit will be ticketed, mechanically restrained* or towed at the owner's expense unless the student has purchased a daily permit.
2. Students wishing to park on campus who have not purchased a semester permit may purchase a daily pass in the front office for \$3.00.
3. Any vehicle parked illegally in fire lanes, handicapped parking areas, or in any parking lot or campus area besides the student parking lot will be ticketed, mechanically restrained, and/or towed. The Buffalo Police Department will issue fire lane or handicap parking tickets.
4. The student under whom the vehicle is registered is responsible for that vehicle's use, regardless of who is driving the vehicle.
5. Vehicles should be locked at all times. The school is NOT responsible for vehicles or their contents while they are parked on school property.
6. Any vehicle parked on campus may be subject to search by a school administrator or school administrator in conjunction with a law enforcement official in instances where the school official determines there is reasonable suspicion that a school regulation, city or state law has been violated.
7. All rules concerning student conduct also apply to student behavior in the student parking lot and with any vehicle on campus.
8. Students are expected to obey all state and local driving regulations.
9. Revocation of permits or other consequences may occur for the following:
 - a. speeding (over 15 mph in the parking lot) and/or careless driving on or near campus
 - b. exhibition of power and/or speed on or near campus
 - c. failure to follow traffic signs on or near campus
 - d. excessive tardiness, absences, or other offenses as determined by the administration
 - e. failing to return school issued athletic equipment following the season of play and also any textbooks, library materials, or any other school property
 - f. other student conduct and/or driving violations
10. Any student leaving campus during the school day must have a valid pass and sign out of the building. A student may not leave campus without a proper pass.
11. Students may not transport other students off campus who do not have a pass to leave school.
12. Lost permits may be replaced at a cost of \$10.00. Permits sold to a student are for use by that student only. All students involved in the purchase and subsequent resale of a permit or using a permit that does not belong to them will be disciplined. Forgery of permits may result in a police citation, loss of parking privileges, suspension, and/or community service.

*A wheel lock may be used for parking violations. Students must pay a \$30 fine to have a wheel lock removed from their vehicle. Students will not be permitted to drive to school until their fine has been paid.
