BHM Schools supports teachers new to the district through the Teacher Induction Program. The goals are to support, guide and encourage new teachers and to advance their skills and knowledge using reflective assessment and continuous collaboration of experienced district teachers in relation to the Minnesota Standards of Effective Practice for Teachers. Improving classroom practices, developing reflective teachers, and building an understanding of student diversity in classrooms are the primary focuses of the program.
