5. ACTION ITEMS

A. 2019-20 Capital Facility Budget, John Heltunen, Director of Buildings and Grounds New server room at the high school will provide this on site instead of at St. Michael-Albertville. Cost savings of \$10,500 per year. This will also allow for competitive bids for our fiber. Media Center remodel at BCMS – money is being set aside. The remodel will also provide some additional walkways to help with hallway congestion. PES gymnasium floor will have asbestos removed and a synthetic floor will be installed. Projects total \$2,356,527.00 for 2019-20.

C. Bid Award - Parking Lot, John Heltunen, Director of Buildings and Grounds This is for additional parking space at the bus garage and includes electrical hookups. Will provide parking for 70 buses onsite. Seven bids were received. Low bid was submitted by Johnsonville.

D. 2018-19 Budget Adjustments, Gary Kawlewski, Director of Finance and Operations Amendments include adjustment to enrollment. The MESI STEAM grant is included in the general fund. Projecting that the unassigned/unrestricted fund balance will end the year at about 8.44%. Expenditures include higher costs for snow removal and heating due to the weather this winter. Food Service meal counts have decreased for lunch and increased for breakfast. Community Education has seen an increase in KidKare, School Readiness and program participation. The Building Fund includes all remaining projects from the 2014 bond question.

6. REPORTS

A. 2019-20 and 2020-21 Budget Update, Gary Kawlewski, Director of Finance and Operations and Scott Thielman, Superintendent

The financial forecast includes numerous assumptions including projected enrollment, formula funding from the State, contract settlements and inflationary increases in supplies, utilities and equipment. Budget adjustments are being made based on the forecast and in order to maintain the district's fund balance policy. For 2019-20, this means a reduction of 7.5 teaching staff, and using \$560,000 of the assigned fund balance and \$608,000 of the committed fund balance to cover the cost of operations. Administration has also been asked to recommend \$725,000 in additional budget reductions. This may include discontinuance of the transportation opt out program, increased parking and activity fees at the high school, energy cost savings, and an additional reduction of 5 teachers along with office staff and administration reductions. For the 2020-21 fiscal year, the board has made the following recommendations: move the fund balance policy to 6% for 2020-21 and ask administration to bring a recommendation for \$2.815 million in program modifications (reductions). A budget reduction committee has been meeting which includes three representatives from the Board of Education.

B. Legislative Update, Scott Thielman, Superintendent 3% and 2% increase from the state recommended by the Governor and House of Representatives. The Senate is at .5% and .5% for each year.
