**General Statement of School District Policy:**

- It is the policy of ISD 877 to prevent and respond to acts of bullying, intimidation, violence and other similar disruptive behavior. It shall be a violation of policy for any student or school personnel to bully.
- The School District will act to investigate all complaints, either formal or informal, verbal or written, of harassment or violence or bullying, and to discipline or take appropriate action against any student or school personnel who is found to have violated these policies.
