6. REPORTS

A. School Start Time Study, Pam Miller, Director of Teaching and Learning and Mark Mischke, BHS Principal

Dr. Rachel Widome, a professor at the U of MN, presented various findings from the study of the change in school start times.

Start times were changed in BHM district in 2016-17. Most teens get less than 7 hours of sleep/night when the recommendation is 8 and even better is 8-10 hours of sleep/night. Teenage students are getting less sleep compared to prior generations of teenagers. Free/reduced and non-white students reported having less than 7 hours of sleep/night before the change. Students needed less hours of sleep during the weekend to catch up with sleep. On average, students are now getting 8 hours of sleep/night. The number of tardies has dropped significantly over the past two years.

Discussion – social media impact – this was not studied along with the increased use of e-cigarettes. Impact of school start times has not been studied. Impact on students who work and participate in activities – looking at that information now. Teachers were not asked if they have changed their personal sleeping habits.
